This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Cronebaugh Auction Service, LTD of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

At times, we may find it necessary to use personally identifiable information to keep you informed of other possible products and/or services that may be available to you from www.cronebaughauctions.com.
